If your tent is larger than 20 feet X 20 feet, there is a \$50.00 fee for tent inspection and permit
****There is a \$25.00 fee for electricity if needed.** Booth fees are refundable if event is cancelled due to inclement weather.
A rain date is not available.

IMPORTANT:

Payment will not be required until you've been accepted as a vendor.
If accepted, you will be notified of your payment deadline, we can then schedule a time to do the payment over the phone within that timeframe. Once you receive the receipt of payment confirmation, you are then locked in as a vendor for the event.

If I don't hear back from you within the payment timeframe, I will move on to the next application.

The application this year does **NOT** have to be mailed in, you can fill it out and email it back to me. I will contact you either way so you will know if you have been denied due to space or a category that is already full.
